- 1b Development relates well to the built form of the town and contributes positively to views of the town, both in relation to the setting of the Conservation Area, and as seen from the AONB, in particular from Watlington Hill.
- 1c Development is sited in such a way as to enhance the setting of historic and listed buildings and other heritage assets.
- 1d Guidelines in the Watlington Design guide are followed, particularly with regard to appropriate materials.

- 4b Development includes, as appropriate, provision for older households seeking to downsize, growing families, home workers, self-builders, and people with physical and sensory disabilities.
- 4c Provision is made for 40% affordable homes on sites of 11 or more dwellings, (except in the AONB), compliant with SODC policy and to meet the needs identified in the Housing Survey 2016.
- 4d Development has high standards of design in accordance with local and national policies and the Watlington Design Guide 2017.
- 4e There is effective connectivity between new housing, the town centre, schools and local facilities by safe pedestrian paths and cycle ways.
- 4f A small site or sites are brought forward for park homes or other low cost homes in line with the findings of the Housing Survey 2016.
