## South Oxfordshire Local Plan 2033

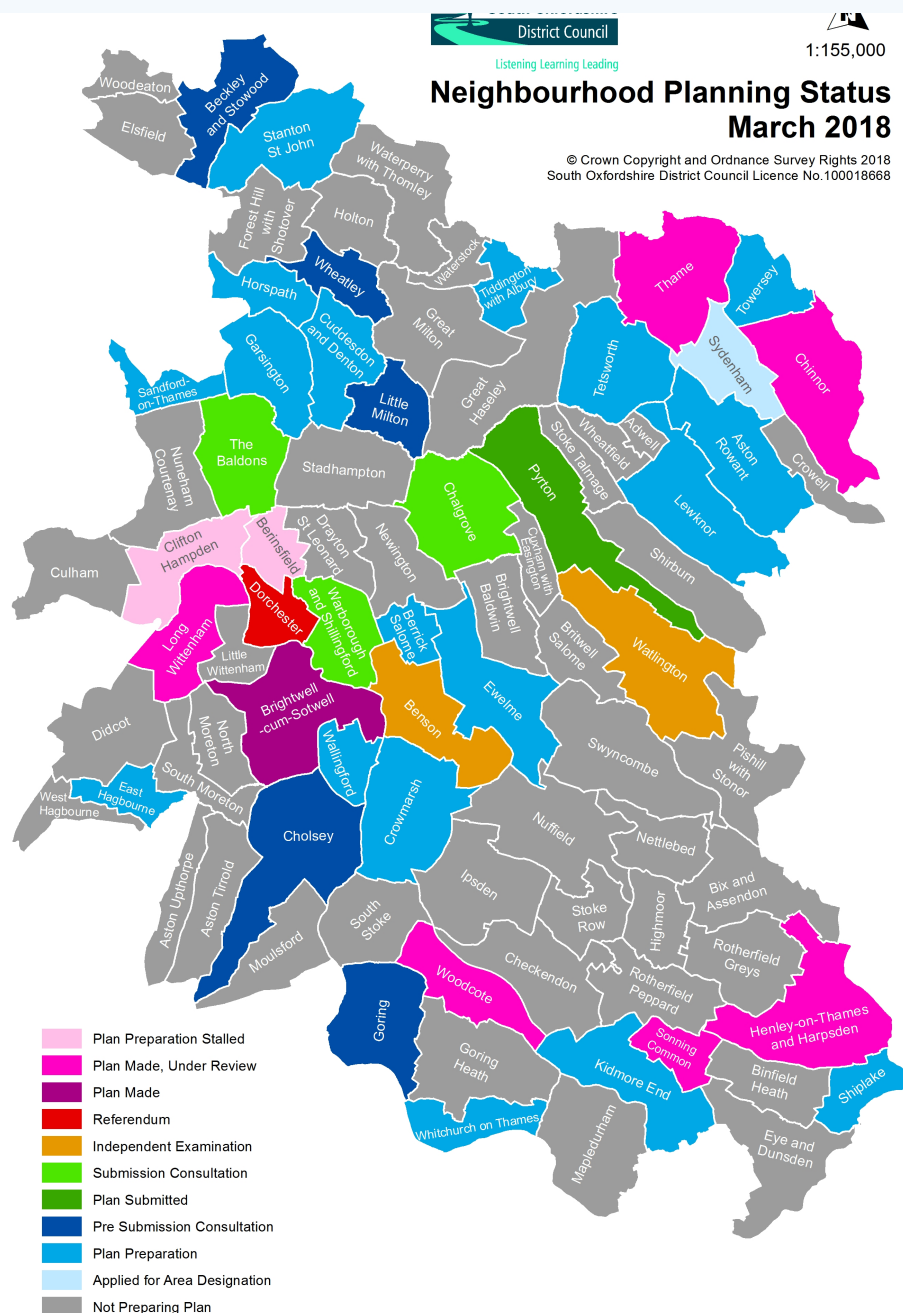
The recent publicity period on our new South Oxfordshire Local Plan was the fifth opportunity you had to have your say on where new homes, jobs, schools and supporting facilities should be located. We received over 2,600 comments from approximately 800 individuals, which are now available to view on our [website](#).

The Head of Planning is seeking a formal decision regarding the progress of the Local Plan following some new information, which is currently being evaluated. There will be a meeting of Cabinet on 20 March to consider this. More information will be available after this date on our [website](#).

## Joint Housing Delivery Strategy adopted

South Oxfordshire and Vale of White Horse District Councils have adopted a new strategy which sets out how we will meet the significant challenge of delivering thousands of new homes over the next 14-16 years.

Our new [Joint Housing Delivery Strategy](#) will work alongside our Local Plan to guide how new homes and infrastructure will be delivered to ensure that the types of homes provided meet the various needs of our communities.

We have published details of all [brownfield development sites](#) in South Oxfordshire which have been promote for residential development and are suitable for housing that have full or outline planning permission. The register includes sites irrespective of whether they have planning permission or not.

## Helping to conserve newts

South Oxfordshire and Vale of White Horse District Councils are two of seven authorities in the South Midlands to receive a 'District Licence' for great crested newts.

This is the first scheme of this scale in the country and will create, restore and manage hundreds of great crested newt ponds and habitats and be a quicker and more cost effective process for developers and planners.
